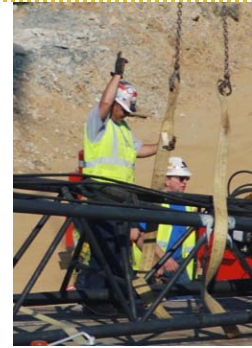


The State of Pennsylvania solicited public comments last month on the proposed regulation that will implement the Crane Operators Licensure Act later this year.
